



Royal Commission into Aboriginal Deaths in Custody Recommendation

66. Encourage more comprehensive research into alcohol use

That if Aboriginal people identify it as a priority, organizations which support research into Aboriginal issues, including the NCADA and the Australian Institute of Aboriginal and Torres Strait Islander Studies, encourage more comprehensive and diverse research into the extent, causes and consequences of alcohol use among Aboriginal people. In particular, that appropriate steps be taken to ensure that the NCADA national research and training centres at the University of New South Wales, Curtin University and the Flinders University of South Australia establish mechanisms to encourage new graduates, researchers from other fields and Aboriginal people to conduct research in this area and identify research priorities and methods to implement them. ¹

Background ²	The Royal Commission into Aboriginal Deaths in Custody (RCIADIC) emphasised the need for more organisations supporting research to fund studies that investigate the consequences of alcohol use in Aboriginal communities. RCIADIC reiterated that alcohol use among Aboriginal communities is the leading cause of deaths in custody, sickness and violence outcomes. The RCIADIC highlighted the need for implementing structures that promote the involvement of a range of experts, researchers and Aboriginal people, ensuring comprehensive research coverage across all areas.	
Intent	Promote comprehensive research into the causes and consequences of alcohol use among Aboriginal people and develop structures that encourage the involvement of diverse researchers and Aboriginal people.

2005 Review ³	The Victorian Government considered Recommendation 66 to be the sole responsibility of the Commonwealth Government.

66. Encourage more comprehensive research into alcohol use		
	The Review Team agreed that Recommendation 66 was primarily aimed at national organisations and research institutions located outside Victoria. However, the team did not agree that the spirit of Recommendation 66 did not apply to Victoria with its considerable research effort in the area. Given the correlation between alcohol and drug abuse and contact with the criminal justice system in Victoria, the Review Team suggested that Recommendation 66 was relevant to Victoria.	
2018 Review⁴	Deloitte considered Recommendation 66 the sole responsibility of the Commonwealth Government and concluded that it had been fully implemented by funding alcohol-related research regarding Aboriginal and Torres Strait Islander people and developing a national initiatives database.	
Since then	Department of Health ⁵ In their 2025 response, the Department of Health deemed this recommendation a Commonwealth responsibility and considered it fully implemented. They noted that the department has not commissioned any comprehensive alcohol related research in relation to Aboriginal cohorts in Victoria.
